

# CITY OF WATERLOO CAMPING REGISTRATION AND WAIVER

The Individual whose name the reservation was made in must be of the Age of 18 years old and will be responsible for the campsite and the occupants.

**CHECK-IN & OUT:** 2:00 pm for check in and checkout is prior to 12:00 noon.

**WRISTBANDS:** The City of Waterloo guests are required to wear a wristband throughout the duration of their stay. Please bring all guests into the office at check in to receive their wristbands.

**OCCUPANCY:** The state of Wisconsin and Jefferson County Health Department imposes the regulation of site occupancy. Sites hold a maximum of 8 guests. Maximum occupancy noncompliance will result in eviction. There must be at least one person 18 and older actually staying on the site

**PRIMITIVE TENT SITES:** There is a maximum of 4 tents allowed on open field sites

**PETS:** Pets are allowed on camping sites. They must be kept on a short leash and kept quiet during the night. Pets are not allowed to be left alone anytime during the night or day. Pets are strictly prohibited in all buildings.

**QUIET TIME:** Quiet Time is from 11:00 pm to 7:00 am. There will be no check-ins during this time. Sounds carry farther at night. Please be considerate of others. Loud noise/music, etc. must be confined in your RV at all times. Loud or abusive language will not be tolerated. Eviction will result without any refunds.

**GROUND FIRES:** Ground fires are allowed in the provided fire rings only. All fires must be attended to at all times and be out by 2:30 am. Please make sure that your fire is fully put out before leaving it unattended.

**CHILDREN:** Kids are the responsibility of the parents and must be supervised at all times. You will be held responsible for your child's safety and actions. Children under 18 must be at their site under parental supervision from 11pm to 7am the next day.

**SITE ACCOMODATIONS:** RV and primitive tent sites include a fire ring.

**SMOKING:** Smoking is prohibited inside any buildings of the City of Waterloo according to Wisconsin State Law.

**VEHICLES:** The maximum amount of vehicles per site varies according to site size and size of camping unit. Most RV sites and open field tent sites can hold a maximum of 2 vehicles; wooded sites hold a maximum of 1 vehicle. There is overflow parking available.

**CLEANING:** Each site must be kept free of loose materials that could cause litter. Trash must be placed in dumpsters before checkout. Dumpsters are located behind Field A in the compost area.

**CRITTERS and HAZARDS:** The City of Waterloo has one of the most enjoyable parks on earth, and insects are a part of that system. We try to control this natural occurrence by regularly spraying for insects. The most common pests are flies, mosquitoes, and wasps. Please let the office know if a site has a problem with wasps' nests. We do not give refunds due to any pest discomfort issue. There are also trees, water, poisonous plants, and everything in-between in our beautiful area. Camping is an outdoor experience and we are not responsible for accidents, injury, or loss of property of any kind. Everyone must sign a participation agreement upon camping in the park.

**COST:** Camping Cost:

- Weekday Stay (Monday PM – Friday AM)
  - \$20/night or \$25/2 nights
- Weekend Stay (Friday PM – Monday AM):
  - \$25/night or \$30/whole weekend
