Dear Public Safety Committee and Common Council of the City of Waterloo,

My name is John Svanda and I am again organizing a "cyclocross" bicycle race that will take place inside of Fireman's Park on Saturday, November 21, 2015. I am excited to say that this will be our third year of operation and the first time the Wisconsin State Cyclocross Championships will take place in Waterloo, WI.

I am again writing to request the temporary closure of a portion of the street that goes through the park. Specifically, I would like to close the westbound portion where it splits into a one-way street near the pavilion and exits onto Spring St. In past years, the street was closed from approximately 7:00 am until 4:30 pm. I would like to use this timeframe again. The eastbound lane and two-way sections of the street shall remain open throughout the day. We will also provide additional signage indicating "CAUTION - Bike Race Ahead," in an attempt to notify motorists driving through the park.

If the city is again willing to provide permission as well as support from the Department of Public Works, I would greatly appreciate it. If there are any questions or concerns, please contact me at your convenience.
