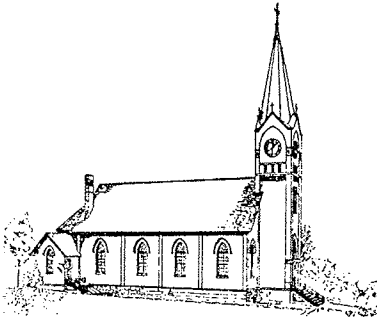

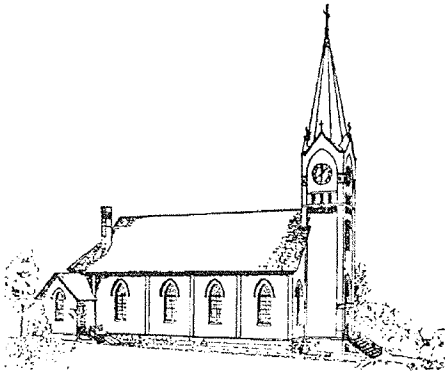

Dear Members and Friends of History,

The Waterloo Area Historical Museum housed in the former St. Joseph's Catholic Church, built in 1869, is losing pieces of brick and mortar in the Steeple Clock Tower which was added in 1888. This tower stands as a landmark to all citizens in the area. After careful examination by four masonry experts, the time has come to repair the steeple to prevent further structural damage. Would you help us preserve this historical landmark?

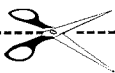
The needed work is restoration of the bricks and mortar of the Steeple Tower, repairing of the leaking roof/shingles, repainting and repairing the louvers and clocks; plan for other minor repairs. The estimated cost of all of this is \$90,000. If this project is delayed, more damage could be done at an increased cost.

We must start by fundraising now. If it is not done now, what are the consequences? This landmark is valued not only for its structure but what we preserve inside the brick walls; artifacts, genealogy data, plat maps and much more.

Please consider a donation to help the Waterloo Area Historical Society to move ahead with the restoration work to preserve the Steeple Clock Tower. We need everyone to join us in our quest to maintain our Museum. **There is a \$10,000 Matching Fund available to begin our Fundraising.**
