## **WATERLOO PARKS COMMISSION – Minutes - Rev.1 07/13/10**

DATE: TUESDAY, JUNE 22, 2010 TIME: 6:30 P.M.

1. Roll Call And Call To Order – *Seidl called the meeting to order at 7:00pm, present: Seidl, Springer, Quimby, Strobel, Mo Hansen, Laura Cotting and Ami Bauer. Absent: Schultz, Kniesel, Yerges.*

2. Approval Of May 4, 2010 Meeting Minutes – *motion by Strobel seconded by Seidl with Springer abstaining, motion carried.*

3. Miscellaneous Communications - *none*

4. Citizen Input - *none*

5. Unfinished Business

a. Dog Park Budget & Concept Layout (Seidl) – *Seidl handout budget preliminary numbers and layout, wants to send to council for approval. Budget does not include labor. Need letter from the Trustees to the City designating the area as a dog park, then forward to the Plan Commission authorizing the use of the land and to council for final approval. Funding is still an issue, Bauer is interested in helping with fund raising. Quimby noted that there was a comment sent to the city stating that they did not want the dog park to be funded by the taxes dog license fee and Quimby stated that the park commission was not seeking tax payer dollars. Motion by Quimby seconded by Seidl to request the Trustees to send the letter and forward to the plan commission and to council as discussed, and to direct Mo to add this item to the Plan Commission agenda.*

b. Approval Of A Draft Request For Proposal For Park Planning Services – Southside Park Development & Comprehensive Outdoor Recreation Plan (Seidl) – *Seidl has additional comments to be added to the document which will be given to Mo to add to the draft for the next meeting. Motion by Quimby second by Strobel to have Mo add to the draft for final approval before sending to council, motion carried.*

c. Parks Commission By-Laws – Tabled From Previous Meeting (Quimby) – *Motion by Quimby second by Strobel to table until further notice, motion carried.*

6. New Business

a. Glacial Heritage Area Implementation – Waterloo/Parks Commission Participation – *Mo mention that some members of the CDA (Cole and Cotting) would like to see the GHA have a permanent home in the parks commission. Springer wants to be sure that the city is not putting any money into supporting projects outside of the city. Mo has been appointed as an advisory group member. He wants to be sure that the city stays involved in the project and have this as a standing item on our agenda. Mo also stated that we should have Waterloo representations on the subgroups. He will add the PC to the distribution list. Motion by Quimby second by Spring to the have the GHA added as a standing item on our agenda with updates by Mo, motion carried.*

b. Hiring A Youth Center Directory – Recommendation Of Chair And Clerk/Treasurer. [NOTE: The commission will convene to closed session to be briefed on this item. The statutory exception for the closed session is Wis. Statute 19.85(1)(c) “Considering employment, promotion, compensation, or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility” Upon conclusion of the closed session the committee will reconvene in open session.] - *Did not go into closed session. Seidl recommended hiring Silha and Mo stated the background checks have all cleared.*

*Motion by Quimby seconded by Strobel to approve the hiring of Silha and Quimby volunteered to assist in any training, motion carried.*

**7. Future Agenda Items, Announcements And Next Meeting Date**

**a. 2011 Budget Considerations – Seidl noted Youker Park: new prairie, grants for way finding signage, paths, property accusation for a south side park**

**b. Ice Skating Opportunity – Seidl wants to see if we can get the ice skate park in yet this year, Springer noted that the wiring and the poses for lighting are still there but the old “Santa house” (which was the shed) has been moved to the Morrison soccer field, need a sand or white shale rock base. Need to discuss with Yerges at next meeting.**

*Strobel noted vandalism at the park.*

*Next meeting Tuesday July 6<sup>th</sup> instead of the regular time of July 13<sup>th</sup>.*

## PHASING RECOMMENDATION

The purpose of this memo is to make a phasing recommendation to bring about the municipal acceptance of an aid award from the DNR for park development at the Knowlton Soccer Field. At its September 2, 2010 meeting, the Council referred the matter of acceptance of this DNR Stewardship Fund award to the Parks Commission.

To qualify for DNR funding up to \$375,000, the City of Waterloo must assemble funds to match the \$375,000. To date Jefferson County has committed to contribute \$25,000 towards the local match.

I am proposing that the Parks Commission forward to the Council a recommendation for phasing the project in the manner listed below. The project items and estimates are taken from form 8700-014 of the DNR application.

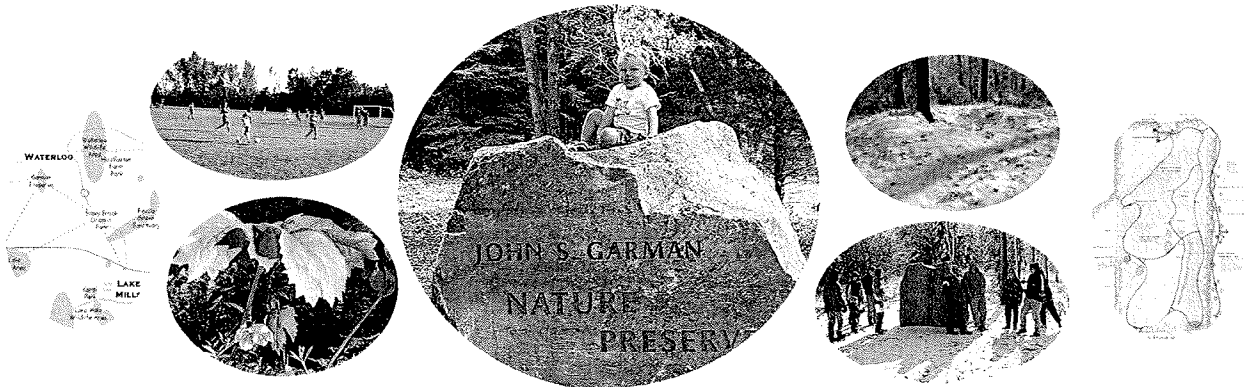
