



WHEREAS, the City of Waterloo has been recognized as a Tree City USA by The National Arbor Day Foundation and desires to continue its tree-planting practices


NOW, THEREFORE, I, Robert H. Thompson, Mayor of the City of Waterloo, do hereby proclaim April 26, 2013 as

"ARBOR DAY"


in the City of Waterloo, and urge all citizens to celebrate Arbor Day and to support efforts to protect our trees and woodlands, and

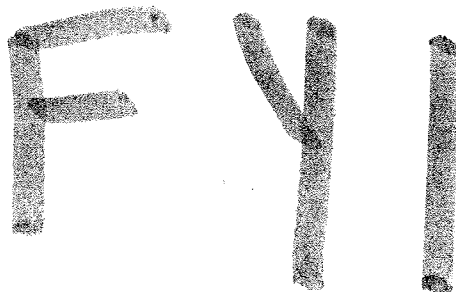

2% Medicare Cuts to Hit Ambulance Services on April 1, 2013

On March 8, 2013, the Centers for Medicare and Medicaid Services (CMS) issued a statement putting ambulance services on notice that starting **April 1, 2013**, their Medicare payments will be **reduced by 2%**. Barring Congressional action between now and then, ambulance services can expect yet another cut to their Medicare rates on all claims with dates-of-service on or after that date.

Since Congress failed to agree on budget cuts last year, the Budget Control Act of 2011 requires mandatory across-the-board reductions in Federal spending, including a 2% cut to Medicare reimbursement. These automatic cuts, known as "**sequestration**," were supposed to go into effect the first of this year. But they were delayed for 2 months by the American Taxpayer Relief Act of 2012, the same Act that extended the ambulance ground bonus payments and will cut Medicare reimbursement for non-emergency BLS transports for ESRD patients. The 2% claims payment adjustment will be applied to all claims after determining coinsurance, any applicable deductible, and any applicable Medicare Secondary Payment adjustments.

Monday March 4th, 2013

On Monday February 11th, 2013 we had our monthly EMS training. First part of training was traumatic injury from slipping on ice. This was done out on the city street. The members had to evaluate the patient and then select the proper equipment to secure the patient's injuries. With the cold we have to try to do the job quick but make sure that the injury is stabilized before moving the patient. The second part was cardiac arrest from a patient that was shoveling snow. The members had to evaluate the patient quickly and then start CPR, get the Lifepak defibrillator on and airway set within 6 minutes and this has to be done outside in the cold to minimize any interruptions so the patient has a better chance. The third part was RIT rehab. With all the training that the fire personnel has been training on with RIT the EMS needs to know what to do and how to take care of this person that has been in that situation. They need to know how to remove the SCBA and turn out gear to evaluate the downed firefighter and treat that person.

On Monday February 18th, 2013 we had our monthly Fire training. First part of training was midnight drills. This is where the personnel has to get there turnout gear, SCBA and air on within two minutes and have the gear on properly so they are not injured when going into a fire. The second part was RIT training. This training was done in pairs where they were getting familiar with the SCBA's. They had to switch air pieces without the firefighter taking a breath, taking your partners SCBA off and putting on yourself.

Tuesday April 2nd, 2013

On Monday March 11th, 2013 we had our monthly EMS training. The first part of training was WEMSA (Wisconsin Emergency Medical Service Association) presentations. This training is done by the personnel that went down to the WEMSA conference and brought back information to share what they had learned from their classes. The second part of training was patient assessments; which had three stations to them. The first one was on difficulty breathing, second was pediatric and the third was a leg entanglement in exercise equipment. With these assessments the EMT's have to assess the patient and identify the problem and provide the correct care. The last part of training was Q & A with Dr. Foster. Dr. Foster goes through all of our reports and makes sure that we are doing a good job with patient care and patient reports.

On Monday March 18th, 2012 we had our monthly fire training. We trained on a new response system (I am Responding) that we are trying out. With this system the members will call in stating they are responding. This will help us out a couple of ways, one way it will help out is we will know how many people are responding to the call and that they have received the call. With knowing how many people are showing up we can get MABAS called out more efficiently. This will also help with our response time getting out the door and we are not sitting around just waiting for personnel to get here. The other part of training was company tours. We had a tour of the new facility Regis Rubber and the Custom Plastics. This will give our members some pre-planning and know what kind of chemicals and the layout of the building is like. The last part of training was on FETN (Fire & Emergency Training Network). FETN is an online training system that all of our members have access to further their education on their own time. With FETN there are multiple areas of training to go through. It is now mandatory that all members take at least one training a month on FETN.

There is now Saturday trainings that we are doing here. This is an extra training that people can come down and train. At this time we are also doing trainings for a RIT team every other week with the personnel that would like to be on the RIT Team.
