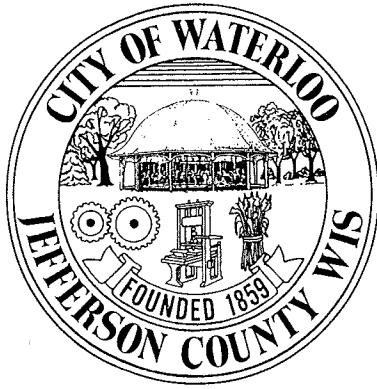

## PUBLIC SAFETY AND HEALTH COMMITTEE MEETING MINUTES

September 5, 2013

### 1. Call to Order

Alderperson Cotting called the Public Safety Committee meeting to order 6:00 p.m.

### 2. Roll Call

### 3. Approval of the August 1, 2013 Regular Committee Minutes.

Motion by Reynolds and seconded by Cotting to approve the August 1, 2013 minutes. Motion carried.

### 4. Citizen Input

Chief Thomas gave a summary of the parking in front of the Methodist Church. The State has agreed to make the area in front of the Methodist church a shared parking/bicycle lane. When the road is rebuilt in 2017, the parking will be eliminated.

### 5. Unfinished Business

#### - Redefining Temporary Sign Permit

Motion by Cotting and seconded by Reynolds to table to the next meeting. Motion carried.

### 6. New Business

#### - Handicap Parking – Waterloo Family Dental, 245 N. Monroe St

#### - Friends of The Carousel – Find Your Path Here – Downtown Waterloo Special Event Application September 14, 2013

#### - No Parking South Side of Taylor Street

Motion by Van Holten and seconded by Cotting to table to the next meeting. Motion carried.

#### - Fire Lane in Front of Park Pavilion

The No Parking – Fire Lanes Signs in front of the Park Pavilion have been taken down. Chief Thomas spoke with Chris Abell. Chris did know why the signs were taken down. He was only able to find one and put it up. Motion by Van Holten and seconded by Cotting to replace the No Parking fire Lanes signs in front of the Pavilion and to paint yellow stripes on the pavement in front of the building. Motion carried.
