

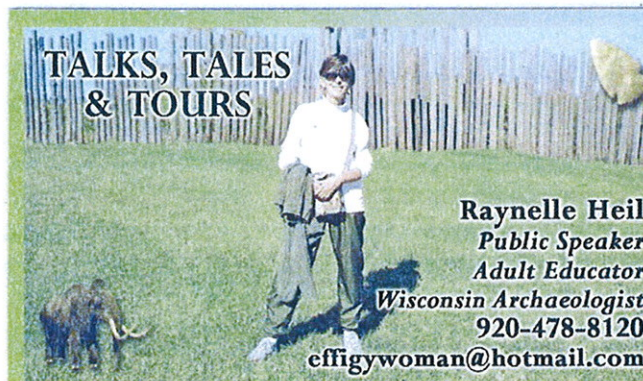

Raynelle W. Heil
registered archaeologist (WI)



September 1, 1954 - July 28, 2013

Raynelle had a gift for combining Native American cultural preservation with astute archaeological scholarship, and she enthralled audiences with stories of the “mysteries” posed by important archaeological sites. Her sensitivity, gentle wit, deep respect for Indian sites, and depth of knowledge connected the public with the human side of the story of the ancient past.

Raynelle had relocated to the Waterloo, WI area over the past few years because of the richness of archaeological sites and Indian mounds in that area. The ancient conical mounds at the Garman Nature Preserve in Jefferson County and the famed earthen pyramids at Aztalan were among the sites she was especially interested in. Last fall, Raynelle made Native American Day at the Garman Preserve Mounds a resounding success by bringing Native representatives, park service employees, archaeologists, historians, and the public together to celebrate the recent restoration of the site. Her eloquent voice will be missed.

Tuesday September 3rd, 2013

On Monday August 12th, 2013 we had our monthly EMS training. We had a special guest come and talk to us about triage. Wisconsin is going to a different way to triage patients on multiple patient scenes. Todd Cole was our speaker. He is an Instructor for MATC and a Madison Paramedic. This way of triaging patients can be from 3 patients and up. It's a fast and efficient way to get the patients to where they need to go. The MASS casualties could be from a crash to a leak of a chemical. The reason why we need to know this is if we come up to a scene with 15 people and there is some that have minor injuries and some that have severe injuries, we have to determine who goes first with severe injuries and who can wait.

On Monday August 19th, 2013 we had our monthly Fire training. Our training was on search and rescue, RIT rescue from a 2nd story floor and Rapid out. The search and rescue is where we have 2 firefighters go into a structure on one side of the interior and search for a person. Once they find that person, they have to get that person out of the structure quick without losing their way. RIT rescue is from a 2nd story floor. There has to be good team work and good communications. Two firefighters go in and find the down firefighter and package him up with a harness. They have to have ladders set up in a way that they can use it as a pulley and lower the firefighter down safely. The rapid out is for firefighter survivals. This is where we have a firefighter on a 2nd story floor and he needs to get out fast. A ladder is placed against the window sill and the firefighter goes out head first grabs the ladder flips around and slides down. This is when the fire is too hot and he needs to get out fast.
