- 3. Action Item: Recommendation re Controversy Regarding Site Excavation Work summary: Additional site work is needed on Knowlton Field before McKay landscaping work can continue. The City engineer's opinion is the work is McKay's responsibility. McKay spokespeople say it is the contractor's responsibility. Mo Hansen and Eric Seidl got 3 bids from local contractors, cost estimate for the work is \$12K. According to Mo Hansen, if that money came from project funds there would be no money left. According to Mo Hansen the project had approx. \$28K as of February, and has spent \$15K since.
