COUNCIL CHAMBER OF THE MUNICIPAL BUILDING – 136 N. MONROE STREET
Thursday, July 3, 2014

1. **CALL TO ORDER AND ROLL CALL.** Mayor Thompson called the meeting to order at 7:00 p.m. Alderpersons present – Ziaja, Griffin, Thomas, Stinnett and Reynolds. Absent – Quimby and Springer. Others present – Police Chief Sorenson, Diane Graff of the Courier, a videographer, Kevin Pickering, Nikki Spoon, Todd Strauss, Amy L. Hopfinger, Sharon Burbach and Clerk/Treasurer Hansen.
2. **APPROVAL OF MEETING MINUTES: June 19, 2014. Motion:** Moved by Reynolds, seconded by Stinnett to approve the June 19, 2014 meeting minutes with the several typographical corrections noted. **Voice vote:** Motion carried.
3. **CITIZEN INPUT.** None.
4. **COMMUNICATIONS TO COUNCIL: 2014 Impact Fees Annual Adjustment.** Noted.
5. **COMMITTEES, COMMISSIONS & BOARDS – RECOMMENDATIONS AND REPORTS**
 - a. **Plan Commission: Kevolutionary Ventures, LLC - 1003 North Monroe Street. Requesting A Change In Land Use From R-2, Single Family Residential District To C-1 General Commercial District For Purposes Of Establishing A Restaurant, A State Approved Kitchen Suitable For Food Processing Services Including Off-Site Sales And Allowing For Fruit And Vegetable Production. Discussion:** Thompson said a Plan Commission public hearing was held on June 30, 2014 and a unanimous recommendation to approve was forwarded. **Motion:** Moved by Stinnett, seconded by Ziaja to rezone the parcel as requested by the applicant. **Roll call vote:** Ayes: Ziaja, Griffin, Thomas, Stinnett and Reynolds. Noes: None with Quimby and Springer absent. Motion carried.
 - b. **Plan Commission: Kevolutionary Ventures, LLC - 1003 North Monroe Street, Requesting A Conditional Use Permit To Allow For Outdoor Restaurant Service And Food Preparation. Discussion:** Thompson again noted that a Plan Commission public hearing was held on June 30, 2014 and a unanimous recommendation to approve was forwarded. **Motion:** Moved by Stinnett, seconded by Reynolds to grant the conditional use permit as requested by the applicant. **Voice vote:** Motion carried.
 - c. **Plan Commission: City Of Waterloo, Firemen's Park 500 Park Avenue, Requesting A Conditional Use Permit To Allow For A Dog Park For The Southern Most Section Of Firemen's Park, South Of The Maunsha River And Immediately West Of The Waste Water Treatment Plant. Discussion:** Thompson noted that a Plan Commission public hearing was held on June 30, 2014. Ziaja said his research showed a significant number of professional certified trainers speaking out against dog parks. He said well socialized animals do fine, but poor dog trainers can produce dangerous incidents. He said the proposed area was too small, raising dog density within the confined area as a concern. Ziaja raised additional concerns about safety. He raised concerns about aesthetics, saying the fence type was not suitable and more fencing would be unsightly in the park. Ziaja raised conservation concerns saying the park should be off limits to dogs in the winter and sanitation was a concern. Ziaja concluded by saying a larger site away from Firemen's Park should be chosen. Reynolds replied saying sanitation was the #1 concern, that volunteers would have to lead on clean-up with two or more annual clean-up days being organized. She said vehicle parking availability was being discussed with the Utility Superintendent as part of the proposed vehicle access to the area was on Water & Light property. She said smaller parks exist as do larger sized parks. She said Ag fence as available is suitable adding that chain-linked fence would be cost prohibitive. In reply to a Thomas question, Reynolds said if parking is not permitted east of the proposed area, dogs would have to be walked on-leash from parking areas located further north in the park, west on Park Avenue or from the Mill Street parking area. Sharon Burbach spoke against the dog park proposal expressing concerns for maintenance in the park. She said the park does not generate enough volunteers currently. She said activities more profitable than a dog park should be considered. Reynolds replied that the plan called for: rounded fence corners; it involved no direct expense to the City; the project had the support of the Trustees; and funding would be self-sustaining by way of a dog park tag purchased to use the park. **Motion:** Moved by Ziaja, to deny the conditional use permit as submitted. **NOTE:** Motion failed due to the lack of a second. **Further motion:** Moved by Reynolds, second by Thomas to approve the conditional use permit as presented. **Roll call vote:** Ayes: Thomas, Stinnett and Reynolds. Noes: Ziaja and Griffin with Quimby and Springer absent. Motion carried.
 - d. **Parks Commission: Resolution #2014-27 2015-2017 Firemen's Park Operations And Management Agreement. Discussion:** Stinnett said the Parks Commission had further work to do on this item. Hansen

said Quimby called saying the same. **Motion:** Moved by Stinnett, seconded by Ziaja to refer the resolution back to the Parks Commission. **Voice vote:** Motion carried.

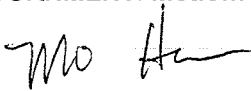
- e. **Public Safety & Health Committee: Waterloo Chamber of Commerce, Application For A Special Event License, September 13, 2014, Wiener & Kraut Festival.** **Discussion:** Thomas said additional time was needed for the two submitting organizations to communicate and reply back. **Motion:** Moved by Reynolds, seconded by Thomas to refer the application to the August Public Safety & Health Committee meeting. **Voice vote:** Motion carried.
- f. **Public Safety & Health Committee: VFW Krause/Langer Post 6614, Application For A Special Event License, September 13, 2014, Wiener & Kraut Festival.** **Discussion:** As above, it was noted that additional time was needed for the two submitting organizations to coordinate and use the same space under a single permit. **Motion:** Moved by Reynolds, seconded by Thomas to refer the application to the August Public Safety & Health Committee. **Voice vote:** Motion carried.
- g. **Public Works & Property Committee: Resolution #2014-31 Awarding A Tree Removal Contract.** **Discussion:** In reply to a Griffin question, it was noted that this project was for mature trees damaging public sidewalks. Hansen said Kunkel Engineering has recommended awarding a contract to Beaver Tree Service of Beaver Dam in the amount of \$13,248. **Motion:** Moved by Reynolds, seconded by Stinnett to approve resolution #2014-31 awarding a tree removal contract to Beaver Tree Services in the amount of \$13,248. **Roll call vote:** Ayes: Ziaja, Griffin, Thomas, Stinnett and Reynolds. Noes: None with Quimby and Springer absent. Motion carried.
- h. **Finance Insurance & Personnel Committee: #2014-32 Authorizing The City Of Waterloo To Enroll As An Experience Works Program Host Agency.** **Discussion:** Hansen noted that the Finance, Insurance & Personnel Committee, at its June 19th meeting, recommended to the Common Council that it authorize the City of Waterloo to enroll as a host community. The program provides senior citizens an opportunity to gain employment skills working in the Clerk/Treasurer's office at no cost to the municipality. **Motion:** Moved by Stinnett, seconded by Ziaja to approve the resolution as presented. **Voice vote:** Motion carried.
- i. **Community Development Authority: Resolution #2014-33 Authorizing The Sale Of 120 West Madison Street.** **Discussion:** In reply to a Sharon Burbach question Hansen noted the statutory exceptions for holding a closed session listed as part of the posted agenda. **Motion:** By consensus the body convened to closed session. **Voice vote:** By consensus the City Council agreed to meet in closed session. **NOTE:** The statutory exception for the closed session was Wis. Statute 19.85(1)(e) "Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business whenever competitive or bargaining reasons requires a closed session." An additional statutory exception for the closed session was Wis. Statute 19.85(1)(g) conferring "... with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved"

Upon conclusion of the closed session the Council reconvened in open session. **Motion:** Moved by Stinnett, seconded by Ziaja to approve the resolution amended adding the following conditions to the approval of the property title transfer to Todd Strauss: (1) The buyer is to furnish a financial statement; (2) the buyer is to agree to enter into a purchase money mortgage; and (3) the buyer is to indemnify the City from claims related to the property. **Roll call vote:** Ayes: Ziaja, Griffin, Thomas, Stinnett and Reynolds. Noes: None with Quimby and Springer absent. Motion carried.

6. FUTURE AGENDA ITEMS AND ANNOUNCEMENTS. # The Independence Day Celebration at Firemen's Parks was announced as being held Saturday, July 5th.

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot.

You must make a request for an absentee ballot in writing.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application for an absentee ballot by mail or in person.

Making application to receive an absentee ballot by mail

**The deadline for making application to receive an absentee by mail is:
5 pm on the fifth day before the election, THURSDAY, AUGUST 7, 2014**

Note: Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

The City must take some responsibility for bringing in revenue, especially since so many others have given so generously to a project that benefits the community and its local businesses. I think it is fair to expect the City to cover utility bills and site maintenance EXCEPT landscaping. The original concept was rental fees covered utility bills. It seems logical to expend effort toward the following:

- 1) City markets facility as a rental and handles rental arrangements. NOTE: Joe Nehmer offered county help in marketing facility as a rental, so you will be getting help with getting the word out.
- 2) Enable online donations through Facebook page and through website. Only you can do that.

Regarding having someone staffing the facility: I recommend inviting Greg Matthews to make his office there. The DNR would appreciate it and Greg salary is already paid for by others.

Regarding 501c(3): there have been preliminary discussions, the initial concern is this could become another dysfunctional and exploitative relationship like the one the City has with the Firemens Park Trustees. Although there is a lot of interest toward fundraising for capital items and a Director, there is no interest in taking over basic maintenance for the City's property.

I would be happy to meet with you and the Mayor to bring you up to date sometime. My time is limited, as I have a mapping contract for next few months.

A Neighborhood Meeting regarding McKay Way Road was held at the home of Maureen Giese, July 28, 2014. The purpose of the meeting was two fold;

discuss why McKay Way Rd was due for "crack filling" on July 18,
secondly, all the overgrowth of vegetation/weeds in the subdivision
located on McKay Way.

Maureen noted she had called the City Hall re: crack filling on the road on **July 18** and complained about why was it done? Who ordered it? The answer from City Hall was a road maintenance industry standard i.e. "Paser Rating" was used, thereby minimizing the lifecycle cost of a roadway. Also a Priority List of road repair was used. The Paser Rating was requested.

The Paser Rating Booklets and 2013 Rating Sheet plus a short list of city streets that were slated for future reconstruction, were delivered to Maureen's home on the 24th for her review.

The three home owners, Maureen Giese, Lee Stock, Darin Pfaff (renting to buy), discussed the above McKay Way concerns.

Thoughts regarding the McKay Way Road.

After reviewing the Paser Rating list which is an acceptable manual to guide local authority to manage local funds for road repair, we found it well written and rating system noteworthy.

However, in the 2013 Paser Rating System McKay Way had a rating of seven "9s" one "8" one "six;" this is 10 -9 being excellent, 8 being Very good, 6 being good. There are numerous streets that have a rating of 1, 2, 3 being Poor.

Question: Why was McKay Way Road cracks being filled? Why was there an interruption of the road at the Apartment section, no cracks or no repair of any kind done, then picked up again toward Hwy 19 intersection?? What good is a rating system if it is not used??

On the Priority "short list" (Public Works Dept.) sent, McKay Way is **not** listed. Of that list is Adams St., Mill St. Rood Ave, Pierce St and Edison Street. Adams St is rated 1 and 2, Mill St. is rated Poor. Additional comments on Adams St. refer to "reprofiled to crack filling."

Thoughts regarding communication to homes on McKay Way when loud equipment/road repair, road closings, and bicycle events are scheduled? *Why*

was there no email, flyer, or newspaper warning given to citizens of these events, esp. "Road Closing?"

Overgrowth of vegetation/grass on McKay Way.

July 3, Maureen submitted a statement to the Public Works Committee Meeting pertaining to the high grass, critters of all sorts, existing on the unsold lots in the DeYoung Subdivision (McKay Way), under the control of John DeWitt and Waterloo Development Group. Maureen was told DeWitt has been fined before because of this and the City is aware of this condition. The July 3rd statement was requested be sent to Mr. DiWitt. Update?

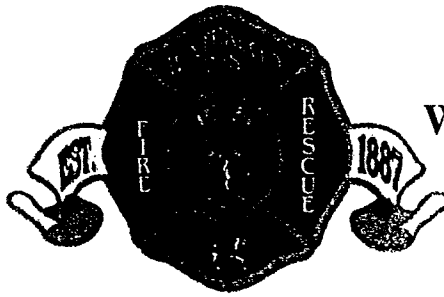
What has been done to date of this overgrowth? Has the commission on weed control issued a notice to the "noxious weed" condition? As cited under 261-8 Weed Control?

On p. 4, under 261-3 Public Nuisances Affecting Health the following points are listed: (H) ...growth of vegetation, and all weeds, grasses and plants over 12 inches in height, excluding trees and shrubs, which:

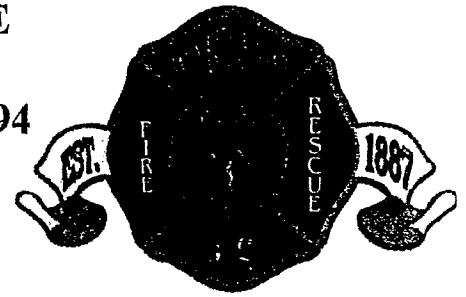
- 1) detract from the surrounding area and properties
- 2) become a possible fire hazard as determined by the Fire Chief
- 3) become a health hazard due to their pollen or a potential cover disease carrying rodents or other small animals,
- 4) are of infectious or poisonous nature in adjacent to a populated area regardless of height,
- (5) become a potential hazard to vehicular traffic in vision clearance triangles.

In conclusion, we feel questions have not been answered to our satisfaction. We would appreciate a complete analysis of the points presented above. Granted, the "crack filling" organization is a credible group of workers, *but was the cost of priority of McKay Way Road justified?*

Due to the City Ordinance Chapter 261 Nuisances, 261-8 Weed Control; if no action is taken by the City of Waterloo, other means of this ordinance enforcement shall be examined.

Monday June 2nd, 2014

On May 12th, 2014 we had our monthly EMS training. We had three scenarios. The first one was a motorcycle accident. We had some of our family members come down that drive motorcycles to participate in this scenario. The crews had to determine if Med Flight was needed and what to do with their injuries. The second scenario was a bicycle accident. One of our member's child was willing to come down with his bike and act like he was in an accident and get splinted and longboarded. The crews had to keep the child calm and take care of the injuries. We also had to try to assist in trying to get ahold of the parents. The third scenario was heroin overdose. Heroin is one of the most used drugs at this time and yes it is in and around Waterloo. Our department is in a program where our EMT's can administer the medication Narcan to counteract with heroin before the AEMT only could administer by IV. There have been many cases in Jefferson and Dodge County with heroin overdoses.

On May 19th, 2014 we had our monthly Fire training. We had two different stations. The first one was a video on Rapid Intervention teams and the rapid growth of fire. The Rapid Intervention Team is about being proactive and being ready. RIT is a team that is set up if a firefighter would get trapped in a structure. Being proactive is making sure when RIT is assigned that they have all the tools they need, making sure that all equipment is set up and ready to use and keeping up with the fire scene. The second station was ladders. With this training we have our splash tower that we use for this training. The members need to place the ladder to the building in a timely manner and which ladder to use. They also went through a window rescue to remove a patient out of the window.
