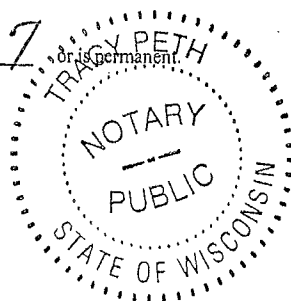

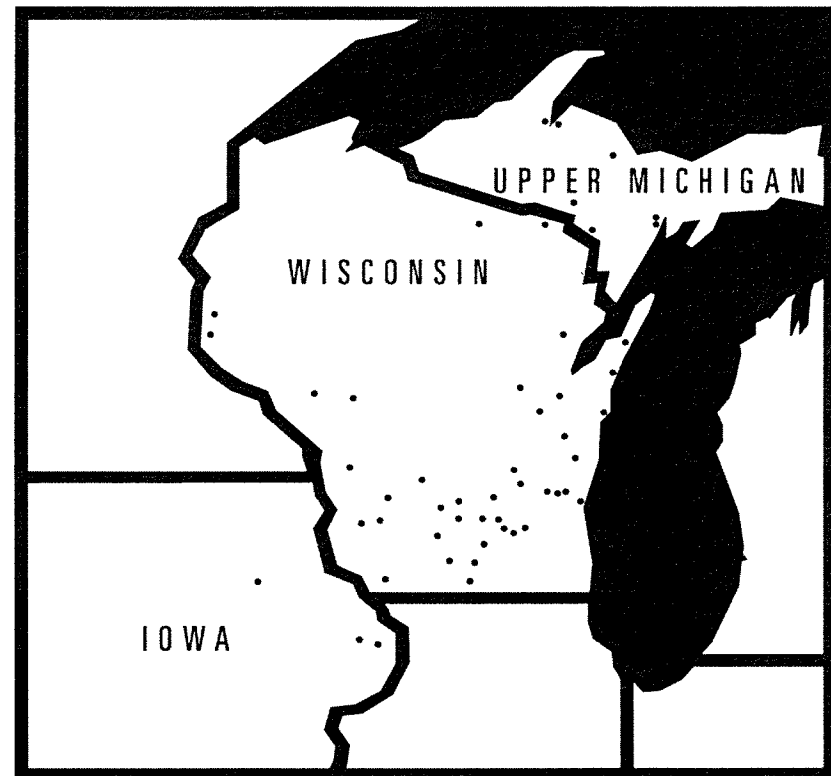
WPPI Energy history

- 1970s: Municipal utilities as 'captive customers'
 - Faced discriminatory rates
 - Little recourse or negotiating power alone
 - Desired independence, ownership and control
- 1980: WPPI incorporated
 - Member-owned, driven

Member governance

- All members have a role in governance
