

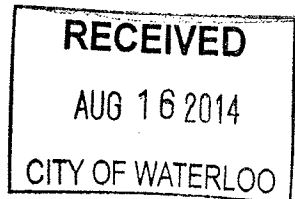

**NOTICE OF PROCEEDING**

**THIS IS A PROCEEDING** to consider the application of the city of Waterloo, Jefferson County, Wisconsin, as an electric public utility, for authority to increase rates. The Commission opens this docket by its authority under Wis. Stat. ch. 196.

The applicant requested an overall increase in annual revenues of \$105,699, or an increase of 2.37 percent over present revenues. The Commission will determine the actual level of the revenue requirement after reviewing the application and holding a hearing. The hearing will be scheduled at a later date. If the Commission authorizes an increase, any impact to individual customers may vary with usage and the ultimate rates authorized by the Commission.

The city of Waterloo is responsible for giving notice to its customers of the filing of its application with the Commission and, pursuant to Wis. Admin. Code § PSC 2.10, for producing proof of notice at the hearing.

This is a Class 1 proceeding as defined in Wis. Stat. § 227.01(3)(a).

**DOCUMENTS.** All documents in this docket are filed on the Commission's Electronic Regulatory Filing (ERF) system. To view these documents: (1) go to the Commission's web site at <http://psc.wi.gov>, (2) enter "6220-ER-105" in the box labeled "Link Directly to a Case," and (3) select "GO."

**INTERVENTION.** Any person desiring to become a party shall file a request for party status, known as a request to intervene, under Wis. Stat. § 227.44(2m) and Wis. Admin. Code § PSC 2.21 no later than 14 days from the date of service of this notice using the ERF system.

At the time of filing, the person making the request to intervene shall serve a copy of the request on existing parties. An existing party may respond to the request within five days of service. A party wishing to request intervenor compensation should do so as soon as practicable.

**WISCONSIN ENVIRONMENTAL POLICY ACT.** This is a Type III action under Wis. Admin. Code § PSC 4.10(3). The Commission will review the potential environmental effects of the project. Type III actions normally do not require the preparation of an environmental impact statement under Wis. Stat. § 1.11 or an environmental assessment.

**ASSESSMENT.** The Commission considers it necessary, in order to carry out its duties, to investigate all books, accounts, practices, and activities of the applicant. The expenses incurred or to be incurred by the Commission that are reasonably attributable to such an investigation will be assessed against and collected from the applicant in accordance with the provisions of Wis. Stat. § 196.85 and Wis. Admin. Code ch. PSC 5.

**AMERICANS WITH DISABILITIES ACT.** The Commission does not discriminate on the basis of disability in the provision of programs, services, or employment. Any person with a disability who needs accommodations to participate in this docket or who needs to obtain this document in a different format should contact the docket coordinator listed below. Friday August 1<sup>st</sup>, 2014

On Monday July 14<sup>th</sup>, 2014 we had our monthly EMS training. The training was a scenario and training on a med sled. The scenario was a CCR (cardio cerebral resuscitation) situation, which is a pulseless non breathing patient that is witnessed. We are able to do compressions without the breathing until we get an advanced airway in. The other part of this scenario is placing an IV in properly and getting the advanced airway in place. Training with the med sled is a review which is not used often. The med sled is used for confined spaces and needs to be properly hooked up to use adequately so not to harm the patient.

On Monday July 21<sup>st</sup>, 2014 we had our monthly Fire training. The training had two stations. The first station was on hose advancements. Two crews have to grab the appropriate hose and advance the hose to the structure, fan the hose out and then, when charged, they have to advance it through the structure and knock the fire out. This station is timed and the goal is when the apparatus stops they have to have the fire knocked down within 2 minutes. The second station is the importance of the first in crew reporting. On any fire the first in crew needs to remember what they see and do while in the structure. The purpose of this training is when we perform our investigation we know how items were set up and entry ways were prior to our extinguishment.
