Monday November 3rd, 2014

On Monday November 10th, 2014 we had our monthly EMS training. The first part of the training was on EBOLA and what should the EMS do if there is a possible case in our area. Columbus ER staff came and discussed what the virus is like, what to look for and what precautions we need to take if there is any possibility of that virus. When it comes down to it, if there is a case of EBOLA and we transport the patient to an ER, our ambulance will be down for 3 days and our members have to be in special suits for this virus or we could be in the same situation the patient was in. The second part of training was divided up. The drivers went out and completed some evasive maneuvers and went over some of the equipment in the trucks. The EMT's went through scenarios. The first one was on CPAP which is used when patients are having difficulty breathing and there are diminished lung sounds. The second part was on maintaining an open airway with all the different types of equipment for that situation. The third part was going over all our meds and what they do when we give them. We also went through protocols on the meds.

On Monday November 17th, 2014 we had our monthly fire training. The first part of training we went to Sussek's for a tour. Sussek's have built on and they are moving equipment around. When we do these tours of businesses around our area we are also completing pre-plans so if there was a fire or a hazard we know what is where and have a lay out of the building. The second part was midnight drills, which is where we have the firefighters put all their gear on and the SCBA with their mask on with air within 2 minutes. With this drill we checked to see if their gear is all properly on and there are no leaks. We have 6 firefighters going through MPO class, which is Manual Pump Operator. Once they have completed the class they will be able to operate the engines here. They also have to complete 7 hours of drive time and complete a driving test with the chief.
