

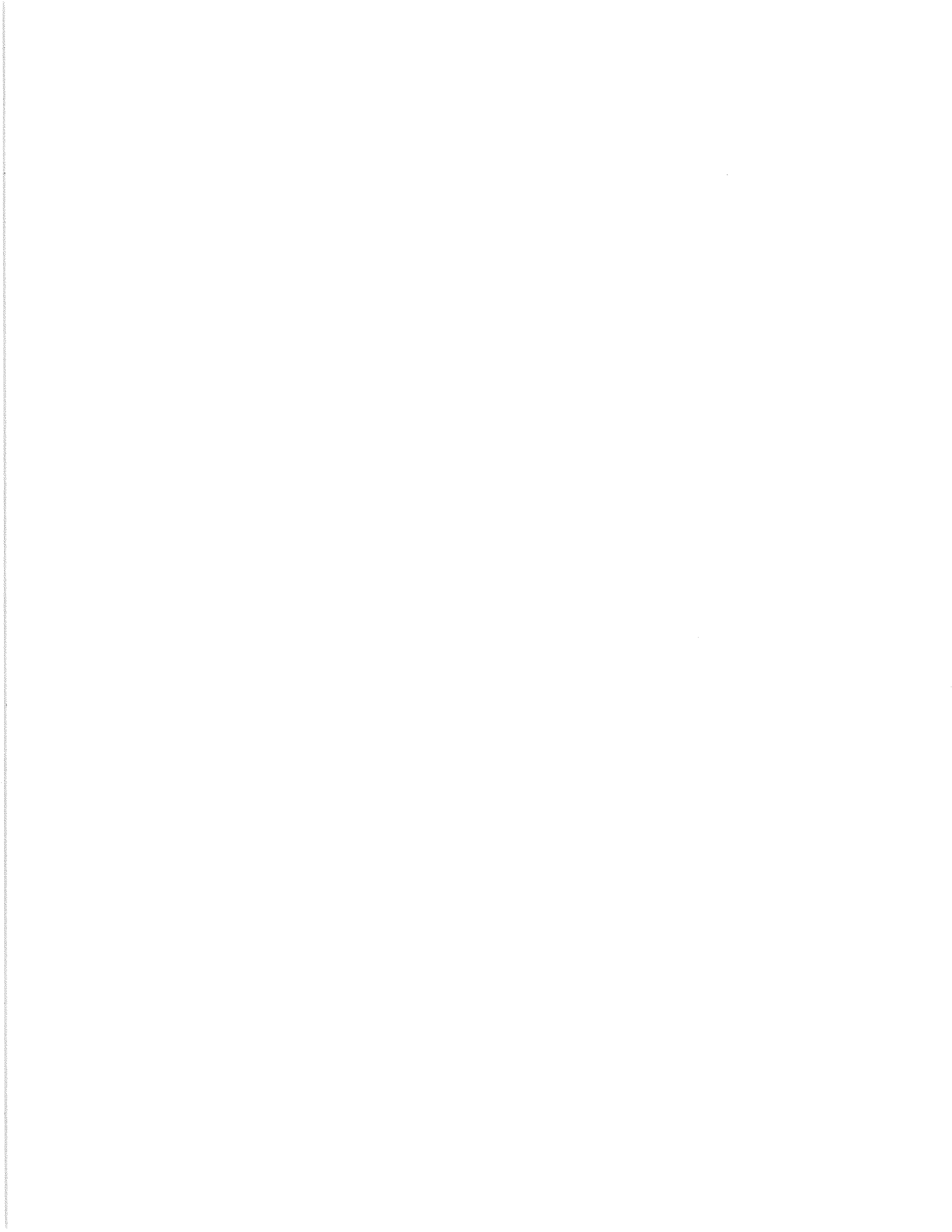

If they don't get checked off they have to practice and retest. For this quarterly we tested on all medications, 12-lead placement, all vital signs, sucking chest wound, IV-IO administration and maintaining open airway.

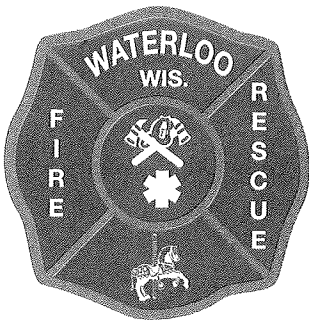
On Monday, January 21<sup>st</sup>, 2013 we had our monthly Fire training. The training was on Midnight timed drills and RIT (rapid intervention team). The Midnight drills are when the members have to get their firefighter gear on within one minute. The second part is when they have to get there gear and SCBA (self-contained breathing apparatus) on within two minutes. The RIT training was when a firefighter went down and the RIT had to search and rescue the downed firefighter. At the Fire meeting there were elections for the Chief position and Vern Butzine was re-elected.

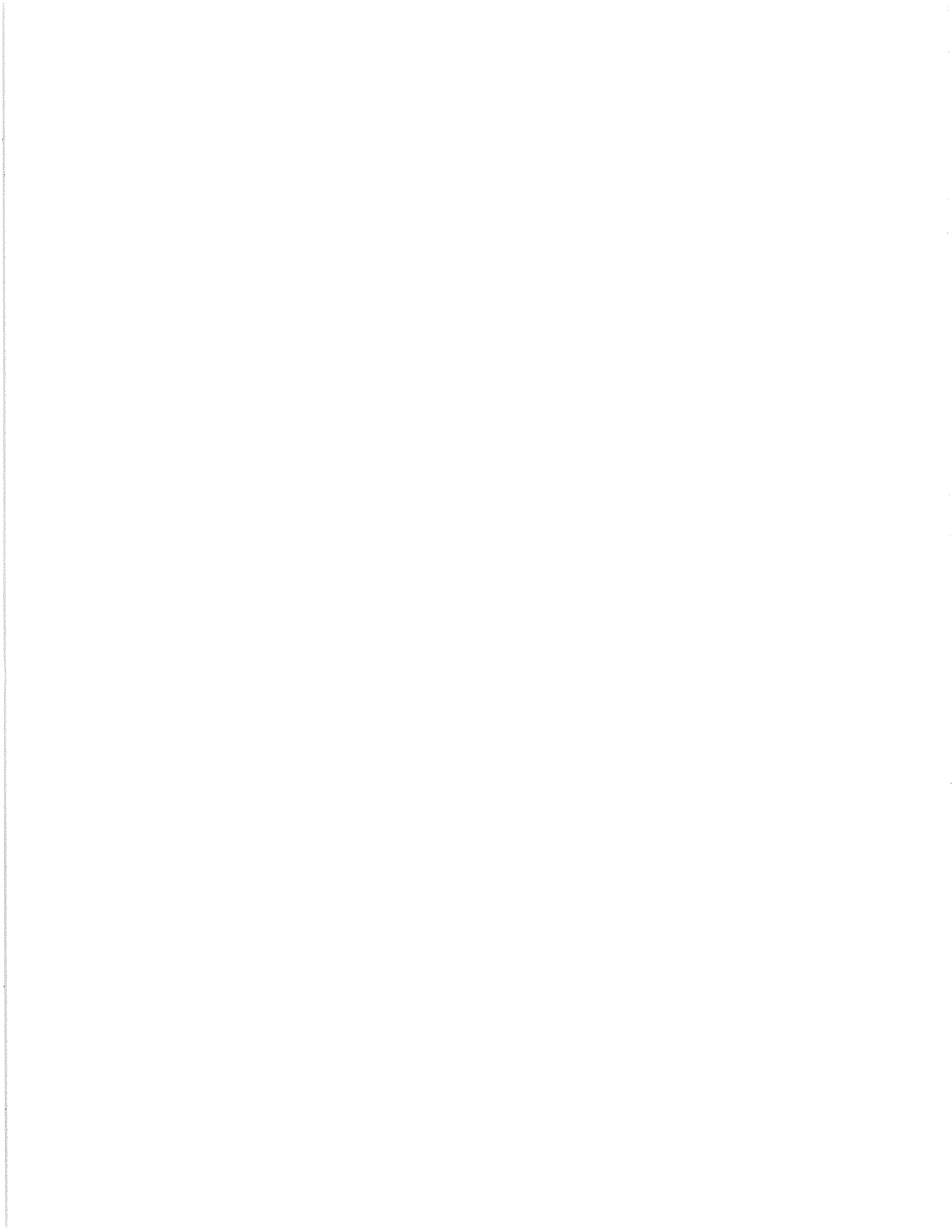

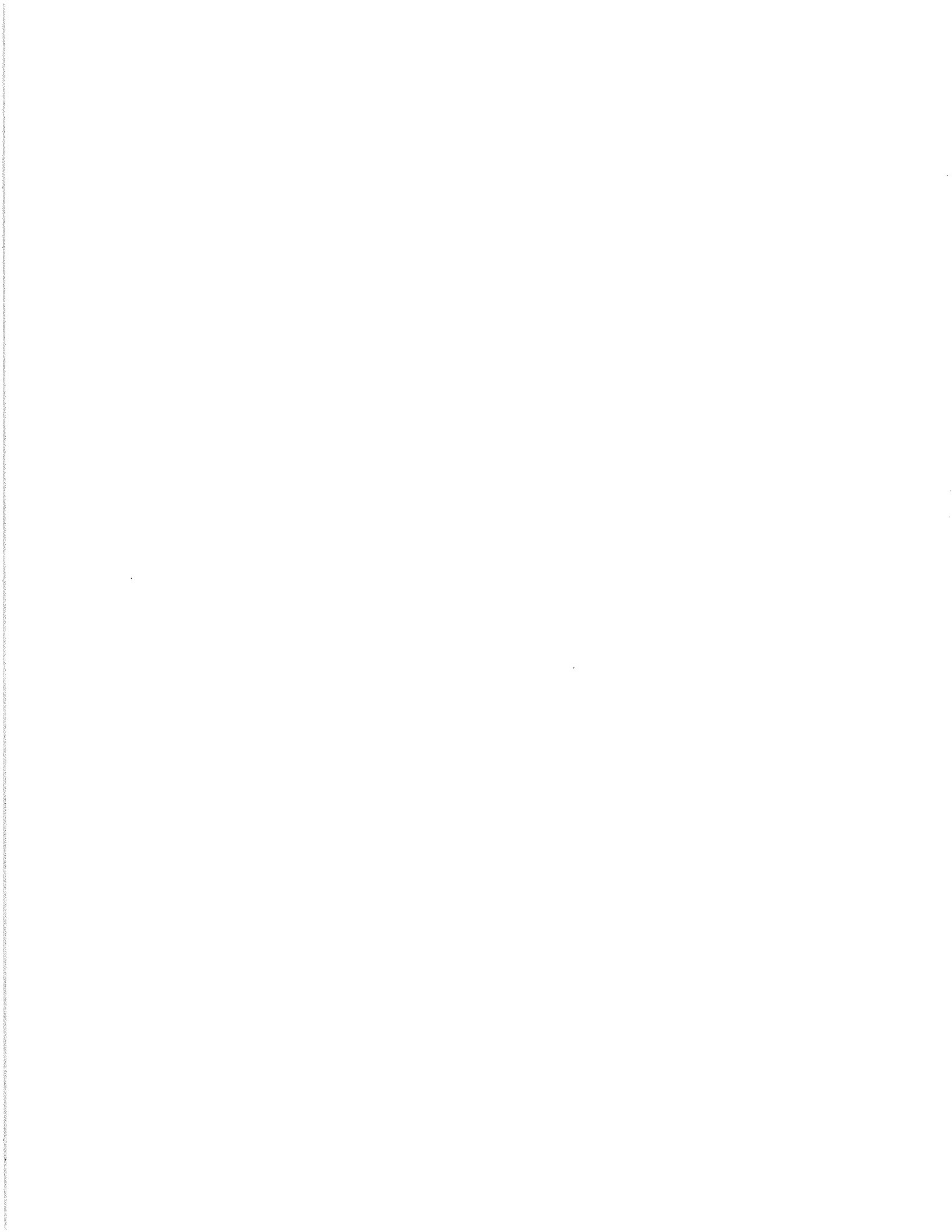
