 - a. Community Development Authority
 - Resolution #2021-01 Authorizing The Sale Of 122 South Monroe Street. DISCUSSION: Indicating the receipt of two sealed bids, Petts informed the Council of a CDA recommendation to sell the property to Quality Control Solutions LLC in the amount of \$30,000. Griffin and Schoenwetter said they had not received bid submittal information. Hansen said it was sent via email to the City Council after the CDA recommendation. MOTION: Moved by Petts, seconded by Kuhl to approve the resolution inserting Quality Control Solutions LLC as buyer, and in the amount of \$30,000.  - Resolution #2021-02 Clarifying The Collection Of Municipal Fees For Residential Construction Of Dwellings Other Than Single-Family Dwellings. MOTION: Moved by Petts, 2nd by Thomas to approve resolution #2021-02. VOICE VOTE: Motion carried.
 - b. Public Safety & Health Committee
 - i. Resolution #2021-03 Obtain Permission From State To Open ATV Routes On State And County Highways Within The Municipality. MOTION: Moved by Thomas, 2nd by Griffin to approve resolution #2021-03. VOICE VOTE: Motion carried.
 - ii. Ordinance #2021-01 Establishing 4-Hour Parking On Knowlton Street From Van Buren Street To McKay Way. DISCUSSION: Thomas asked that the matter be tabled. He said Knowlton Street narrowness and no nearby alternate street posed challenges. He said Van Buren was even more narrow. Apartment property owner Jim Derks said he thought the street had been widened previously to address narrowness recalling a special assessment to do so. Derks said the Police Chief indicated only accidents involving vehicle side mirrors. Derks said he would contemplate constructing garages on his property to help minimize the need for onstreet parking. Derks asked that no parking – only during snow events - be investigated. Thomas welcomed Derk's willingness to add off-street parking. Quimby noting the ordinance

was drafted to go into effort in September asked attendees to consider action this night or tabling. MOTION: Moved by Thomas, 2nd by Petts to table the ordinance, referring the matter to the Public Safety & Health Committee. VOICE VOTE: Motion carried. ADDITIONAL DISCUSSION: Schoenwetter asked that the municipal standard of 1.5 parking stalls per dwelling unit be reevaluated.

Tuesday February 9th, 2021

On Monday January 4th, 2021 we had our monthly Operators training. Training was with the new Engine. Members had to show that they knew how to complete a full truck check on the new engine.

On Monday January 11th, 2021 we had our monthly EMS training. Training was on the new LUCAS device and quarterlies. Our members went out to the community and raised money to get a LUCAS device. This device is used on patients that need CPR. It will do the compressions for us. This will help reduce injuries while in the back of the ambulance. Before the device we would have to be standing while driving down the road doing compressions. Every quarter we have to complete certain trainings to make sure that all our members are proficient at their job.

On Monday January 18th, 2021 we had our monthly Fire training. Training was on mask up drills, hose advancement drills and the Sensit monitor (gas detector). For mask up drills our members don't mask up until they get to the door. We save energy and mask fogging up prior to going in. So our members have to get their mask on at the door in 15 seconds or less. The hose advancement drill is where the members have to advance the hose down, get to the door and go over the proper tasks. For instance, advance hose to door, kneel on the hose and call for water, mask up, bleed the hose and then advance into the structure. The goal for all members to be able to do this all under one minute. The Sensit monitor is our gas detection device. Our members reviewed how to use it and how to read it.

RESOLUTION #2021-04

Authorizing A 2021 Lead Service Line Replacement Program For Private Property Owners

The Common Council of the City of Waterloo, Wisconsin does hereby resolve as follows:

Whereas, the City of Waterloo Comprehensive Plan calls for Waterloo to be a Green and Healthy Community, and;

Whereas, the Federal Environmental Protection Agency has set the maximum contaminant level goal for lead in drinking water at zero because lead is a toxic metal that can be harmful to human health even at low exposure levels. Lead is persistent, and it can bioaccumulate in the body over time, and;

Whereas, Waterloo Utilities has found elevated levels of lead in drinking water in some homes and buildings. Lead can cause serious health problems, especially for pregnant women and young children. By removing lead water services in-home water quality will improve, and;

Whereas, the Clerk/Treasurer's office has sought additional grant funding and has been notified of a forthcoming Wisconsin Department of Natural Resources grant award estimated at \$237,041.

And Whereas, a program allocating a prior round of funding was administered by the Clerk/Treasurer's office.

Therefore, Be It Resolved, that the Waterloo City Council takes the following action:

- 1. It pro-actively accepts the Wisconsin Department of Natural Resources grant award and directs the Mayor and Clerk/Treasurer to review and sign all documents related to the grant.
- 2. It authorizes the immediately implementation of a 2021 Municipal Lead Service Line Replacement Program in accordance with Wisconsin Department of Natural Resources program requirements with the following grant allocation instructions:
 - a. Municipal grant awards benefitting qualifying properties are to cover 75% of qualify contractor costs with a maximum award of \$3,750.
