Sunday September 1<sup>st</sup>, 2024

On Monday August 5<sup>th</sup>, 2024 we had our monthly Operators training. Training was on hose testing and cross-lay pressures. Hose testing has been completed and had about 10 sections of hose that failed and those have been taken out of service. We practiced and tested out how much the operator needs to how the pressure at to get the right gallons per minute from the size of the hose we are using and the style nozzle. This helps the firefighters control the hose and nozzle control.

On Monday August 12<sup>th</sup>, 2024 we had our monthly EMS training. We had three parts to training this month, first was an update on our reporting system some changes that we changed and a few that the state is mandating. The second part was on a medical game of guess who. This is where a team has to try and guess what medical problem the other team has. This game helps members think outside the box and not to have blinders on. The third part is a Styker rep came out to demo the Lifepak 35 and we drove around in the ambulance to make sure the road condition did not mess up the unit. Let's face it Wisconsin does not have the best roads, so we are making sure that we try to make sure our equipment works properly going down the road. The current Lifepak's are going to becoming obsolete so we are looking at different monitors. These are required to be able to send information to the hospitals so they can prepare for the patient.

On Monday August 19<sup>th</sup>, 2024 we had our monthly Fire training. Training was done out on Deppe Lane, Mr. Deppe has allowed us to train on an abandon house that is on his property. We trained on laddering the roof from the ground and from the aerial.

The ground laddering was also part of venting the roof. They have to sound the roof to make sure it is safe to step on and the properly cut the roof sections out to get the heat and gases out of the structure.

The aerial laddering was the operators properly position the aerial to the structure where the firefighter can carry a roof ladder up and place it on the roof and dismount the aerial to the roof ladder with ease.

The last part of the training was VES (Vent Enter Search). VES is done by checking the structure figuring out which windows would be the bedrooms. If need to ladder to the window, taking the window out and gaining access to the room. Once in the room find the door or make a door to close off that room and then complete a search to find victims and get them out the way they came in.
